Invoice for Royalties on PVMI Varieties for the 2010 Crop

Please fill in the information below as it applies to you and the PVMI varieties you grew in 2010, return it with your check for the royalties within 30 days of sale. The royalty assessment is a flat rate fee based on where you are located, where the seed is grown:

- \$0.25/CWT for seed grown in the Tri-States
- \$0.50/CWT for seed grown in the US and outside the Tri-States
- \$1.00US/CWT for all seed grown outside the US).

Examples to calculate royalties due:

2400 CWT PVMI seed grown in North Dakota -	2400	x	\$.50	=	\$1,200
6000 CWT PVMI seed grown in Oregon	6000	x	\$.25	=	\$1,500
1150 CWT PVMI seed grown in New Brunswick, Canada	1150	x	\$1.00	=	\$1,150

PVMI recommends that you pass the cost of royalties onto the buyer, as a line item, in the same way you would for shipping.
